

User Agreement

1. General provisions

This User Agreement (hereinafter referred to as the "Agreement") regulates the relations between SIGMA EXPO GROUP LLC Rus LLC (OGRN (Primary State Registration Number) 1227700183215, TIN (Individual Taxpayer Number) 7743378236, address: sh. Dmitrovskoye, 71B, floor 6 rooms. 4/6, municipal district Western Degunino, Moscow, 125504) hereinafter referred to as SIGMA EXPO GROUP LLC and any person who, after accepting the terms of this Agreement, becomes a user of the website located on the Internet at: www.ctt-expo.ru , www.ctt-digest.ru , www.construction-innovation.ru , www.cto-expo.ru, www.ktt-magazine.ru , www.comvex.ru , www.best-comvehicle.ru , www.logistika-expo.ru , www.food-expo.com as well as all sites of other SIGMA EXPO GROUP LLC projects (hereinafter – Site), hereinafter referred to as the "User" of the Site.

In addition to this Agreement, the relationship between the User and SIGMA EXPO GROUP LLC may also be regulated by other special documents posted in the relevant sections of the Website on the Internet.

The resources and services of the Site, its content and materials, including information about planned events (schedules, announcements, etc.), are the property of SIGMA EXPO GROUP LLC.

2. Agreement Status

This Agreement is a public offer. The use of the Site by the User means the User's accession to this Agreement, thereby creating a contractual relationship between the User and SIGMA EXPO GROUP LLC on the terms of this Agreement in accordance with the provisions of Articles 437 and 438 of the Civil Code of the Russian Federation. 5. Data Processing

6. Rights and Obligations of the Parties

- b. Refuse to register a User without explaining the reason;
- c. Send the User informational messages and personalized messages related to the activities of SIGMA EXPO GROUP LLC by sending messages to the email address specified by the User when registering on the Site;
- d. Disclose information about the User if the current legislation of the Russian Federation requires or permits such disclosure;
- e. Perform other actions provided for by this Agreement and the Privacy Policy and not prohibited by the legislation of the Russian Federation.

The User shall be entitled to:

- a. Gain access to the use of the Site after meeting the registration requirements;
- b. To use all available online services (services).

The User agrees to:

If it is impossible to resolve the dispute on a voluntary basis, either Party has the right to apply to a court located in Moscow for the protection of their rights, which are granted to them by the current legislation of the Russian Federation.

Any claim regarding the terms of use of the Site must be filed within the period after the grounds for the claim arise, with the exception of copyright protection for the materials of the Site protected in accordance with the law.

11. Additional provisions

This Agreement comes into force for the User from the moment of his accession to the Agreement and is valid for an indefinite period.
